

## RoHS Compliance Declaration

**'DIRECTIVE (EU) 2015/863 of 31 March 2015 amending Annex II and 2011/65/EU of European Parliament and of the Council on the Restriction and Use of Certain Hazardous substances in Electrical and Electronic Equipment (Recast)'**

Dear Valued Customer,

This is to certify that the Southco part number R4-50-30-1EA1-10 is in compliance with both **Directive 2015/863/EU (a.k.a. RoHS 3) amending** Annex II dated March 31, 2015, and **Directive 2011/65/EU (a.k.a. RoHS 2) of the European Parliament and of the Council of June 8, 2011 on the restriction of the use of certain hazardous substances in electrical and electronic equipment (EEE) – recast.**

The substances restricted by both Directives have not been intentionally added above the threshold limits specified by the Directives, and reproduced below from Annex II of **Directive 2015/863/EU.**

| Restricted Substance                  | Maximum Limit           |
|---------------------------------------|-------------------------|
| Cadmium and its compounds             | 100 ppm (0.01 weight %) |
| Mercury and its compounds             | 1000 ppm (0.1 weight %) |
| Hexavalent chromium and its compounds | 1000 ppm (0.1 weight %) |
| Lead and its compounds*               | 1000 ppm (0.1 weight %) |
| Polybrominated biphenyls (PBB)        | 1000 ppm (0.1 weight %) |
| Polybrominated diphenyl ethers (PBDE) | 1000 ppm (0.1 weight %) |
| Bis(2-Ethylhexyl) phthalate (DEHP)    | 1000 ppm (0.1 weight %) |
| Benzyl butyl phthalate (BBP)          | 1000 ppm (0.1 weight %) |
| Dibutyl phthalate (DBP)               | 1000 ppm (0.1 weight %) |
| Diisobutyl phthalate (DIBP)           | 1000 ppm (0.1 weight %) |

\*Except when allowed by the Directive 2011/65/EU as per the exemptions listed in Annex III.
